District Chair's Pastoral Letter

Dear Friends,

Who is my neighbour?

Many of us will have been reminded of and will have reflected again on last Sunday's gospel reading about Jesus's encounter with the lawyer (Luke 10.25-37). First there is the sharing of the great commandment: "Love the Lord your God with – all of your being, and your neighbour as yourself", chosen as their Presidential theme by the new President and Vice President of the Methodist Conference, the Revd Graham Thompson and Mr Anthony Boateng; followed by the parable of the Good Samaritan.

When we come to the parable, often our first instinct is to position ourselves as the Good Samaritan and to recognise the invitation, indeed command, to go and do likewise. First, however, maybe we also need to think through some possible similarities with the other characters in the story?

We are critical of the lack of concern and apparent hypocrisy of the priest and Levite who pass by on the other side. Yet being 'good' according to the principles of the day meant avoiding contact with a dead body (they would have had to go over to check whether the person lying in the gutter was alive or dead), for it would have made them unclean. It would have prevented, for example, the priest from going to take a service and perhaps having to let down a congregation, etc.. Yet, as both Jesus' audience and we can see, by observing the inherited understandings and practice, the priest and Levite missed the bigger point that the Samaritan fulfilled, the need to show compassion and care for the one in need.

Quite apart from our own failure often to care for those in need, how might our present understanding of faith, and present practices and ways of organising ourselves in church, get in the way of us seeing or delivering on the bigger picture, including joining in effectively with God's concerns and mission at the present time? We are living through a period of ecumenical and Methodist reconsideration and reorganisation at local church, mission community and circuit, county and regional layers, and thank you for increasingly engaging with this. How might we better lay down (or share) some of the less important things in order to release ourselves and others for getting on with what is more important, and for which we are called upon to use more effectively our time, energy resources, including to care deeply for our neighbours?

Then, in recent years, we have increasingly been invited to imagine ourselves as lying in the gutter, in need of help, and to consider the possibility that this might not come from someone like us but from a 'Samaritan' (of all people, Jesus' hearers might have said)! What then if the one whom we naturally dislike, of whom we might be instinctively wary, disapproving or fearful (as Jews and Samaritans were of each other), turns out to be the one whose help and mercy we really need? In such an imagined or real encounter, can we reappraise and reappreciate the 'other'? How might we then with humility learn from the 'other', from the one whose background, behaviour or even understanding of God is different from our own? Is it from them that we might need to receive grace and understanding (and, through them, such things from God)? Remember how we sing: "pray that I may have the grace to let you be my servant too" (STF 611).

Having imagined ourselves into the shoes of the priest or Levite, and then as the one set upon and lying in the gutter, might our understanding of what it means to be a 'Good Samaritan', be deepened and increased?

For in all of this, Jesus is 'turning the flank': of the questioning lawyer, of those who were listening to him, and of course to question our own understanding and presumptions. The question: "Who is my/our neighbour?", becomes: "To whom might I/we be called to be a good neighbour, to whom we can show care

and compassion, and – most importantly – from and with whom I/we can learn and work to establish justice and restoration?"

In our individual and collective ecumenical and Methodist life, at all layers and in all places, may this question lie at the heart of who we are and of what we are about, as we work at letting go and sharing to focus on what is most needed, as we engage in God's love for all in this part of the world.

As you ponder this, may you also know some rest, refreshment and renewal this summer, and thank you, and God Bless you, for all that you are and do,

We learnt a lot about climate change and also had good worship and fellowship. It was good to meet up with friends old and new from other circuits. It is always interesting to know what other circuits are doing and if not much is happening in your circuit at the moment, then come along to district events and meet other Methodist Women.



The day started with a bit of admin, telling us what was happening over the next year, presenting accounts etc and then worship.

Then Dori Henderson, who is an Anglican member of the East of Eden Mission Community, spoke about climate change with a lot of good slides. She explained what is happening and about temperatures rising and some of the reasons for this and about globally what governments are doing about it. But for me the most interesting part was what can we do about it and about living sustainably. 'Think globally, act locally' was a phrase used a lot ie think about the world but do things locally to help eg Reduce food waste, avoid palm oil, eat less meat, buy less stuff, use charity shops, responsible travel, plant a tree, reducing plastic etc etc. One thing I learnt a lot about was recycling, I didn't know we could recycle as much as we can eg Did you know that someone is making crisp packets into blankets for the homeless?

We then had a break for lunch, we all had a packed lunch but drinks and biscuits (chocolate of course) were available or there was a shop close by if you hadn't brought enough to eat! There was time to visit the bookstall or have some fresh air – it was a beautiful day. I spent most of the time chatting to people from other circuits, catching up with old friends and making new ones.

After lunch we broke into small groups and had a discussion answering 4 questions


- How can we encourage a shift from 'what we want' to 'what we need'?
